- Refuge Services Residential Dump Truck Rental & Dumping 100% Discount of \$75 (Week) or \$100 (Weekend) Rental Fee – Council & Employees – Pay tonnage only to Waste Management at \$40 per ton
 - Town of Chesapeake Citizens pay \$75 during the week and \$100 for weekend dump truck drop off + tonnage at \$40 per ton. The driver takes the key, then returns the next morning or on Monday after the weekend. Drives truck to Waste Management in Kanawha City, weighs, and dumps.
 - 2. Resulting in an invoice based on:
 - Rate = \$40 per ton
 - Previous Administration Dump Truck Rental is free to Council and Employees – One Ton at Waste Management – Council & Employee pays for tonnage over the one ton.
 - If free, cost of Labor (\$17.00 per hour for 2 hours), Insurance, Fuel, and Maintenance must be considered
